## 10:30 Future Vision Commission Charge and Process

Staff reviewed Council engagement on the Future Vision, next steps, process outcomes and principles.

Staff turned to the proposed charge for the Commissioner: to recommend a vision; generate participation; serve as ambassadors; and to consider current conditions, trends and futures, and community values.

Councilor Rosenthal asked how Metro can consider lessons learned from past processes to avoid unintended consequences in the next iteration of the Future Vision. Staff pointed specifically to the fact that past Future Visions were not well-known within the community despite engagement.

Councilor Hwang asked how Metro can remove silos and promote cross-sector collaboration and suggested bringing various audiences together. Staff referred to other regions that could serve as inspiration for this type of collaboration and noted that the team is also working with Metro's Social Innovation Director on partnerships.

Councilor Lewis thanked staff for capturing Council feedback and remarked that commissioners will represent multiple communities and viewpoints at once, which may
