WHEREAS, the State of Oregon has implemented the Oregon Housing Needs Analysis (OHNA) program to encourage the production of housing that meets the needs of current and future households; and

WHEREAS, the OHNA program requires Metro to adopt a regional housing coordination strategy no later than one year after the deadline for completing a housing capacity determination under ORS 197A.350; and

WHEREAS, on December 5, 2024, the Metro Council adopted the 2024 Urban Growth Report via Ordinance No. 24-1520, thereby completing its statutorily required housing capacity determination; and

WHEREAS, according to the schedule adopted by the Oregon Land Conservation and Development Commission, Metro must adopt the 2025 Regional Housing Coordination Strategy by December 31, 2025; and

WHEREAS, Metro has undertaken extensive engagement with local jurisdictions, housing providers, developers, and a variety of interest groups and housing experts to identify barriers to housing production and actions for possible inclusion in the 2025 Regional Housing Coordination Strategy; and

WHEREAS, on September 15, 2025, Metro released a draft 2025 Regional Housing Coordination Strategy for public review by interested parties; and

WHEREAS, Metro held a public comment period on the draft Regional Housing Coordination Strategy from September 15, 2025 through October 15, 2025; and

WHEREAS, the Metro Committee on Racial Equity discussed the 2025 Regional Housing Coordination Strategy on two occasions, providing staff with feedback on a preliminary list of actions and the framework for evaluating actions; and

WHEREAS, the Metro Technical Advisory Committee discussed the Regional Housing Coordination Strategy on six occasions and provided recommendations to the Metro Policy Advisory Committee; and

WHEREAS, the Metro Policy Advisory Committee discussed the Regional Housing Coordination Strategy on six occasions and recommends that the Metro Council adopt the 2025 Regional Housing Coordination Strategy; and

WHEREAS, the 2025 Regional Housing Coordination Strategy addresses the requirements specified in ORS 197A.365; now therefore

BE IT RESOLVED that the Metro Council adopts the 2025 Regional Housing Coordination Strategy attached to this resolution as Exhibit A.
