1. Call to Order and Roll Call

Council President Peterson called the Metro Council meeting to order at 2:01 p.m.

2. Safety Briefing

Council President Peterson called on Councilor Stacey to provide a safety briefing. Councilor Stacey provided a safety briefing for the meeting including information on the location of emergency exits, fire extinguishers and automated external defibrillators.

3. Public Communication

<u>Bill O'Loughlin, City of Portland:</u> Mr. O'Louhglin, President of O'Loughlin Trade Shows, expressed concern for the development opportunity study overview of the Expo Center. He provided data on the Expo Center and shared the personal experience of his family in producing shows at the center. Mr. O'Loughlin highlighted the center's economic value to the region and advocated for making repairs, increasing parking capacity and celebrating the center's rich history. (Mr. O'Loughlin submitted written materials with his testimony; see the November 7 meeting materials).

<u>Michael Goff, City of Hillsboro:</u> Mr. Goff stated his support for Metro's long range transportation planning specifically the TV Highway corridor updates. He shared concern that generally land use planning was not coupled with the transportation planning and discussed the importance of land use and zoning upgrades along corridors.

5. Resolutions

 5.1 Resolution No. 19-5049, For the Purpose of Recognizing the Observance of Veterans Day on November 11, 2019 in the Greater Portland Region

> Council President Peterson called on Mr. Paul Slyman, Chief of Staff to the Metro Council President, to provide a brief presentation on the resolution. Mr. Slyman introduced the resolution and called on Mr. Darrell Jones, Ms. Laura Brokaw, Mr. Juan Gracia, Ms. Comara Thomas and Mr. Mike Amodeo, Metro staff, to share their experiences as veterans.

Mr. Darrell Jones shared that joining the Navy gave him a sense of direction, taught him accountability and provided an opportunity to work with a diverse group of colleagues. He discussed his success in the Navy, returning to the civilian work force through a job at the Oregon Convention Center. Ms. Brokaw discussed her experiences in the Army highlighting the value of feeling part of a larger community through her service. She shared challenges veterans experience in finding work after service.

Mr. Garcia discussed his personal experience in the Marine Corps, explaining the difficulties and reward of being a member of the armed forces as an undocumented person. He shared his transition to work at Metro from the armed services and thanked his wife for her partnership during difficult times of his service in Iraq. Ms Thomas expressed her appreciation for her experiences in the Air Force and shared her family's history serving in the armed forces. She discussed the values she learned during her service, highlighting the alignment of these values with Metro's values.

Mr. Amodeo shared his experiences in the Air Force, noting the opportunity that the military gave him for a successful career in occupational safety. He discussed the challenges that veterans and active duty members face and highlighted the importance of supporting service members to eliminate veteran suicides.

Mr. Slyman explained that over 70 veterans were current employees of Metro and discussed the shared values that veterans held.

Council Discussion:

Councilors expressed their gratitude for the service of active duty members and veterans and thanked Councilor Dirksen for bringing the resolution forward to recognize veterans. Councilor Dirksen shared that Metro representatives would march in the Veterans Day Parade and asked Council and staff to join him. Councilors Chase, Gonzalez and Stacey

Mr. Johnson provided an overview of the proposed updates to the Metro Solid Waste Code, explaining that these four ordinances would amend Metro Code to provide greater clarity and predictability, update outdated code sections and provide greater flexibility for Metro to protect the public's interests. He noted that the amendments would reduce confusion in the code on the regional system fee and Metro's transfer station rates in addition to establishing administrative rule-making procedures for the solid waste code. Mr. Johnson reviewed the public comment process and summarized the comments received.
